

**WEST GOSHEN TOWNSHIP
BOARD OF SUPERVISORS MEETING
February 28, 2007**

A regular meeting of the Board of Supervisors of West Goshen Township was called to order by Chairman Dr. Robert S. White at 4:00 p.m. on Wednesday, February 28, 2007, at the West Goshen Township Administration Building. Mr. Meakim was absent. Dr. White opened the meeting with the Pledge of Allegiance to the Flag.

Dr. White opened the floor for public comment. No comments were made.

Dr. White announced that Supervisors Hearing S-08-06 which was scheduled for today to hear the application of The Benson Companies for the property located at 901 N. New Street has been continued to April 11, 2007 at 4:00 p.m.

Dr. White announced that the Board of Supervisors met in Executive Session on February 26, 2007 to discuss personnel matters.

On motion by Ms. McIlvaine, seconded by Dr. White, the Board unanimously approved the bills to be paid from the General Fund, the Sewer Fund, the Capital Reserve Fund, and the Waste and Recycling Fund.
