

**WEST GOSHEN TOWNSHIP

A regular meeting of the Board of Supervisors of West Goshen Township was called to order by Chairman Patricia McIlvaine at 7:00 p.m. on Wednesday, April 9, 2014 at the West Goshen Township Administration Building. Mrs. McIlvaine opened the meeting with the Pledge of Allegiance to the Flag.

Township Solicitor Kristin Camp and Township Special Counsel Margaret Morris presented an update on the Sunoco Logistics Zoning Hearing Board Application and Application before the Pennsylvania Public Utility Commission. After lengthy discussion and questions from the audience (**please see official transcript**), the Board approved the following motions:

On a motion by Mr. Corvo, seconded by Dr. White, the Board unanimously agreed to appear and intervene at the May 1, 2014 Zoning Hearing Board meeting.

On a motion by Mr. Corvo, seconded by Dr. White, the Board unanimously agreed to intervene through a filing with the Pennsylvania Public Utility Commission in the Sunoco case, with intervention petitions due April 21, 2014.

Joseph Gleason, Chief of Police, gave the Police Report for the month of March 2014.

Ms. Andrea Testa gave the Fire Marshal Report for the month of March 2014. Ms. Testa also gave the report for Good Fellowship Ambulance Company and the Goshen Fire Company.

Mr. Beswick gave the Building Official's Report for the month of March 2014.

Mr. Halvorsen announced that this coming weekend was very busy with scheduled Township activities, including the annual Easter Egg Hunt and Decorated Hat Parade, Saturday, April 12th, 10:30 AM at Community Park; the monthly curbside yard waste collection is Saturday, April 12th; the first paper "Shred-It Saturday" event is scheduled for 9:00 AM – noon this Saturday, April 12th; and the annual Earth Day, Goose Creek Cleanup is scheduled for behind the McDonald's on Gay Street starting at 9:00 AM to noon, Saturday, April 12th.

Mr. LaLonde announced that at 7:00 PM, Monday, June 23rd in the main meeting room of the West Goshen Township Building, Sean Moir will be presenting the full "Battle of the Clouds" multi-media presentation highlighting the Revolutionary battle that occurred in portions of West Goshen Township and East Goshen Township on September 16, 1777. The public is cordially invited to attend.

Mr. LaLonde also announced that the second Rosedale Avenue Corridor Traffic Study Public Workshop will be held on Wednesday, April 23rd in the main meeting room of the West Goshen Township Building. A representative of Gilmore & Associates will be on hand to present feedback received from the first public workshop and detail recommendations on improving traffic and pedestrian flow on Rosedale Avenue.

On a motion by Dr. White, seconded by Mr. Corvo, the Board with a 4-0 vote approved the Board of Supervisors meeting minutes of March 12, 2014. Mr. Murphy abstained as he was absent from the meeting on March 12, 2014.

On a motion by Mr. Halvorsen, seconded by Dr. White, the Board unanimously approved the Treasurer's Report dated March 31, 2014, for the General Fund, the Sewer Revenue Fund, the Waste and Recycling Fund, and the Capital Reserve Fund, and the bills to be paid from these funds.

Ms. Camp presented Ordinance No. 2014-1, revising Section 84-8 of the Township Zoning Ordinance to revise the definition of Women's Temporary Residential Care Center; to revise Section 84-22.1 to allow one bedroom apartments in a Women's Temporary Residential Care Center; and to revise the off-street parking regulations for a Women's Temporary Residential Care Center. On a motion by Dr. White, seconded by Mr. Corvo, the Board unanimously approved Ordinance No. 2014-1.

On a motion by Mr. Halvorsen, seconded by Mr. Murphy, the Board unanimously approved Barry Isett & Associates as a 3rd party electrical inspector for West Goshen Township.

There being no further business, on motion by Dr. White, seconded by Mr. Halvorsen, the meeting was adjourned at 9:12 p.m.
